## **ARTICLE - 2**

### **( PURPOSE )**

To organize, educate and make consumer aware of the rights and make best efforts to stop unfair trade practices and solve consumer problems/complaints.

### **AIMS OF THE ORGANISATION :**

### **ORGANISE EXIST :-**

#### **CONSUMER PROTECTION ACT, 1986 (68, of 1986), 24th Dec. 1986.**

An Act to provide for better protection of the interest of consumers and for the purpose to make provision for the settlement of consumer councils and other authorization for the settlement of consumer and disputes and for matter connected therewith.

### **ARTICLE - 3**

#### **( MEMBERSHIP )**

- (I) Any person may be appointed as member of the Organisation by paying the fees with the consent of the National President.
- (ii) Membership on the basis of race, color, creed, religion national origin, ancestry, citizenship, gender, sexual orientation, age on disability.
- (iii) Membership of Organisation shall be open to anyone who is interested in helping the people to achieve its aim and willing to abide by the rules of the Organisation .





- (iv) The disciplinary committee shall have the power to refuse membership to an applicant where it is considered such membership would be detrimental to the aims, purpose on activities of the state organisation.
- (v) Registration, reporting and termination -
  - a) Any member of the State Organisation may be resign his/ her membership and any representative / member of the organisation on section may resign such position, by giving to the President/Gen. Secretary of the organisation written notice to that effect.
  - b) The recommendation of the Disciplinary Committee shall be discuss with Founder Chariman.
  - c) Hard copy or all application forms complete with photo either original or copy submitted.
  - d) Report File (annual) with all events/programme photograph, newspaper cutting & all correspondence and minutes with financial transaction & reciepts in hard copy (submitted upto Feb. every year).
  - e) Any Printing Material regarding to promote Yourself / Organisation or any Event without prior permission. Identity Cards will be issued from the Head Office only.
  - f) Termination in case of any disobeying, ignoring, neglected, misbehavior of anyone as per hierarchy of National President or using abusing to anyone / anti Organisation activities / Inactive/ Non Performance / Criminal / Forgeries found against you.
  - g) Termination also if misuse of any funds non submission of bills & enclosures in excel sheet as & when requirement.
- (vi) The Organisations activities will be run by the following Four Committees -
  - (i) CORE COMMITTEE (CC)
  - (ii) ADVISORY COMMITTEE (AC)
  - (iii) FINANCE COMMITTEE (FC)
  - (iv) PLANNING COMMITTEE (PC)
- (vii) (I) (i) The Core Committee shall meet once in a month preferably every 4th Saturday or Sunday to review the activities / programmer under taken during the month. The decision of the Committee will be final and binding.
- (ii) They will look after the discipline of the members and if they found any guilty then he/she will be disqualified from the Organisation with prior notice from the Committee.
- (iii) They will look after the management of the office as well the Seminars, Meeting,



- (III) The Finance Committee will look after the financial part of the Organisations. Every members has the right to know the financial status of the Organisations every year.
- (i) Any money obtained by the State Org shall be used only for the Organisation.
  - (ii) Any cheque issued must be signed by the signing authority.
  - (iii) The finance committee has the power to raise money by mean of membership fees and contribution from other sources.
  - (iv) The funds income (including interest of funds) and property of the Organisation shall be appropriated solely towards the promotions of the objects and aims of the Organisations and no portion thereof shall be transferred by way of profit to any member of the Organisations providing that nothing herein shall prevent the payment in good faith of reasonable and proper remuneration to any office Bearer on the repayment of out of pocket expenses and on presentation of receipts to the Treasurer. The membership fees for any financial year shall be decided by one Financial Committee.
  - (v) The organisation financial year shall run from 1st April to 31st March.
  - (vi) The Treasurer shall submit the Annual accounts which will be reviewed and passed after discussion by the General Body & send to National Office.
- (IV) Planning Commtee
- (i) They will organise day to day programme of the organisation every year.
  - (ii) They will look after the awareness programme in every of the state every year.
  - (iii) They will arrange the meeting of the organisation and they will decide what issue shall we discuss in the meeting.

## **Responsible of each Positions**

**(A) ADVISORS :** Take an active role in advising the members of the organisation. He/She should meet the President of the organisation at least once per month for guidance of the organisation on goal setting, organisation management, program planning, problem solving and group evaluation. During emergency of the Organisation at such an event the advisor should express his /her least judgment and work closely with the public safely. .

**(a) PRESIDENT -**

- (i) The president shall have the full power to act on behalf of the committee in urgent matters which may arise provided that his/Her action is reported to and confirmed at the next General meeting.
- (ii) He/She shall guide and supervise the awareness activities of the organisation. He/She shall preside over the general body committee meetings and at the disciplinary committee meeting and others. The president should give signature to the organisation.
- (iii) The President in case of emergency may exercise all the powers and perform all the functions required to be exercised and performed under the Rules and Regulations by the General body committee provided always all the action taken by the President shall be placed before the general body committee in the next meeting immediately following the exercise of such power and functions by the President.

**(b) LEGAL ADVISOR -** He / She will look after the legal side of the organisation and he will advise every committee what are the proceedings and series should be followed in every work in the organisation.

He/She will provide advice to the clients on Legal issues, documents and decisions. He/She will work for the organisation legal disputes between the other organisation or government/private agencies as well as the clients or consumers of the organisation.

**(c) VICE PRESIDENT -** Due to the absence of the President in a committee meetings. He/She will preside the meetings and will look after the organisation for the betterment of the Organisation.

The Vice President of the organisation shall enjoy all the power of the President in the absence of the President with the permission of National President.

**(d) GENERAL SECRETARY -** The general secretary shall be in charge of all executive work of the organisation. He shall keep records of the office of the organisation and issue calls for various meetings. He will act under the guidance, supervisor and advice from the President and the General Body Committee. He will prepare proceedings of the meetings and get them approved by the President.



**(e) ORGANISING SECRETARY** - They will look after smooth agenda of the meeting which are effectively organised and minuted. Maintaining effective records and as administrator of the organisation. He/She shall look after and develop the District Committee and Block Committee and will take advice from the President of the State organisation and shall give information about the activities of the District as well as Block Committee.

**(f) JOINT SECRETARY** - To exercise powers of functions which are provides by the regular and such powers as are delegated by the Executive committee from time to time. He/She plays important role in organisation and helps to grow your business with handling the such a great responsibilities. The role of Joint Secretary is to support the General Secretary in ensuring the smooth functions of the Management Committee. Ensuring meeting are effectually organised and minuted. Maintaining effective records and administration.

He or She will look after the District Committee as well as the Block Committee.

The District Committee & Block Committee will inform the State Joint Secretary about their issues and the proceedings of the meeting and them approved by the State President / Vice President of the Organisation.

(I) The committee shall call at least one general body meeting each year the purpose of the meeting is for the organisation to account for its action and consider the regeneration and development of according to the organisation objectives.

(II) The President of the organisation shall normally chair the meetings.

(III) At least 14 days notice of such a meeting must be given and advertised in at least 3 public places.

(IV) All meetings must be minuted.

**(g) TREASURER** - A watch role overall aspects of General management working closely with other members of the General body committee to safeguard the organisation finances. The treasurer duties will vary according to the organisation size and culture but financial Committee is a team responsibility.

All funds of the Organisation shall remain under the care and management of Treasurer. Treasurer shall maintain the accounts of all which are received and paid by him on behalf of the Organisation transactions.

Treasurer shall make disbursement as per the direction of General Body Committee.

**(h) JOINT TREASURER** - He/She support the Treasurer in every financial part of the organisation .





- (i) **EXECUTIVE COMMITTEE MEMBERS** - The Committee will maintain close contact with the organisation . The Executive Committee will keep the organisation informed of important issues and membership development & awareness.

## **ARTICLE - 5**

### **ADMISSION & QUALIFICATION FOR MEMBERSHIPS**

The membership of the organisation shall be only for the Consumer Rights Organisation, India.

### **SUBSCRIPTION OF THE MEMBERSHIP**

The Membership Fees (Non-refundable) and the subscription shall be as under unless otherwise revised by the National Body / Core Committee of the organisation .

## **ARTICLE - 6**

### **MEETING AND QUORUM**

- (a) The quorum for a Committee meeting shall be five (5) members of the committee.
- (b) The committee shall be accountable to the members at all terms.
- (c) All meeting must be minuted and made available to any interested member.
- (d) All committee members shall be given at least (5) days notice of a meeting unless it is decided an emergency meeting.

## **ARTICLE - 7**

Given the organisation nationwide membership and the cost of postage the committee will endeavour to communication with members by electronic media whenever possible.

- s. To encourage discussion among groups on problems affecting rural communities.
- t. To enhance micro enterprises in rural and urban areas by providing them guidelines and financial help.
- u. To establish student hostel and health gym.
- v. To arrange science and technology for rural development.
- w. To setup Jan Shikshan Sansthan.

### CONSTRUCTION

- a. To solve urban/rural housing problem.
- b. Construction of link road, low cost houses and latrines(sanitation programme) for people living below poverty line, like free bonded laborers, marginal farmers, landless farmers etc.
- c. Repair and maintenance of tenements builds, especially for the weaker sections of the community.
- d. Construction of rural and urban building center and community center.
- e. Construction of affordable houses or distribution of plots for under privileged and people below poverty line.

### CONSULTANCY

- a. To provide consultancy for various projects in different fields of development sector.

- b. Cultural heritage of different tribes all over india and abroad.

- e. To conduct cultural program/activity for fund raising of trust development.

## **DISASTER MANAGEMENT**

- a. In the event of natural calamities such as draught, floods and cyclones:
  - i. To undertake voluntary work for victims of calamities through contribution, shramdan, govt. help Etc.
  - ii. To arrange financial assistance from central/state govt. and voluntary Organisation .
  - iii. To organize and maintain a youth task force for rendering on th spot service during disasters and natural calamities.
  - iv. To maintain and orient the people of flood and drought prone areas in advance to own preventive measures.

## **EDUCATION & EMPLOYMENT**

- a. To establish and provide educational centers/schools/institutions for non-formal education, school education, higher education, vocational education/training, computer education, education in engineering, education in business management, education in medical sciences, nursing college etc.
- b. To facilitate self employment by delivering technical and financial services to the women and unemployed youth of the rural and urban areas through cooperation from state/central govt. / govt. bodies.
- c. To establish child labor schools at grass root level, block level, district and state level.
- d. To run courses of different languages.
- e. Organizing and running of adult education centers.
- f. To set up libraries and reading rooms conduct study classes and organize cultural activities.
- g. To encourage the rural/urban/slum people to adopt the latest technology in the field of education.



- h. To create employment opportunities for men/women and youth through vocational training facilities to trace out skilled force of women/youth.
- i. To establish and maintain youth centers/theaters/libraries/reading rooms/information centers, hostels, training and educational institutions for job oriented courses.
- j. To start Ashram schools and secondary and higher secondary schools for boys and girls from backward classes.
- k. To help the govt. in organizing and successfully completion of literacy mission.
- l. To conduct various research studies in the field of education.
- m. To provide sex education to adolescent girls and boys.
- n. To apply for all schemes provided by government in education sector.
- o. To work for promotion of Skill Development and other govt. schemes implemented by state or central government in education sector.

### **ENERGY**

- a. Encouraging the use of alternative sources of energy, like solar cooker, Bio-gas smokeless chullas etc.
- b. To promote non-conventional energy sources.
- c. To enhance the use of solar energy.

### **FOREIGN COLLABORATION AND CONTRIBUTION**

- a. To obtain foreign collaboration for transfer of rural technology, marketing processes, etc. from donating agencies in foreign lands.
- b. To obtain the sanction from Govt. of India (Home Ministry) for receiving foreign contributions.
- c. To open a separate bank account for foreign contributions and maintain the accounts properly.
- d. To utilize foreign contributions so received for the up-liftment of weaker sections and marginal farmers in the rural sector with a view to ensuring the greatest good of the greatest number.

### **FORESTRY**

- a. To implement various programmers of social forestry, tree plantation, community forestry etc.
- b. To raise nurseries of various plants for income generating purposes.





## **GENDER**

- a. To implement issues related programs.
- b. To work for implementation of Pre-Natal Diagnostic Technique (PNDT) Act.
- c. To implement projects on Gender Sensitization.

## **HANDICRAFT**

- a. To promote Handicrafts by developing artisans.
- b. To implement the schemes/programs of various institutions/departments engaged for development of handicraft sector like KVIC, SIDBI, Ministry of Textile, NABARD, WDCA Department of Rural Development etc.
- c. To run projects for development of handicraft through participation of Craft persons.
- d. To upgrade artisan's skill through appropriate design & technology intervention.
- e. To provide necessary market support and service to the product/craft persons.
- f. To implement schemes of sericulture sector, wool sector.
- g. To run projects, scheme of nation of center for jute diversification.
- h. To setup training cum production centers for promotion of jute diversification.

## **HEALTH AND FAMILY WELFARE**

- a. To run first aid and primary health center.
- b. To provide facilities to people of mobile dispensaries, Medicare unit.
- c. To carry out immunization nutrition for health, medical checkup and blood donation programs.
- d. To propagate family planning schemes by supporting social programs like marking of condoms etc.
- e. To run reproductive and child health programs.
- f. To provide free medical aids to the aged men and women, the handicapped, widows, free bounded labors and weaker section of the rural/urban population.
- g. To provide portable water and rural/urban people.
- h. To setup hospitals, dispensaries and schools in rural/urban areas, where the existing medical care and educational facilities are inadequate/required.



- i. To start national health programs for leprosy blindness, TB cancer, RTI/STI/HIV/AIDS and other non-curable diseases.
- j. To provide counseling services to people living with anxiety of the unknown in pretest and post test counseling for HIV and to work for prevention of STD/HIV.
- k. To fight against drug abuse.
- l. To initiate nutrition program for health of women and children.
- m. To provide health training.
- n. To conduct health training eyes camps for the masses.
- o. To help the disabled persons purchase fitting of aids/appliances.
- p. To motivate the people for using the India system of medicine and homeopathy.

### HELP TO POOR AGED

- a. To provide free medical aid to the aged, men and women.
- b. To setup poultry/fishery/dairy units to keep elderly occupied as also to generate income for them.
- c. To arrange free feeding of elderly rural poor.
- d. To set up an ASHRAM "apna Ghar" for old people with financial assistance from the central govt. and donations from voluntary agencies.
- e. To setup DAY CARE Centers for aged.

### HUMAN RIGHTS

- a. To promote & educate Equality, as well as Equity, International Integration, Brotherhood, Non-Violence, Love, Peace, Justice, Protection & Promotion of Human Rights for all.
- b. To suggest action for violation of rights by armed political groups and terrorists.
- c. To create an environment as well as an understanding that Human Rights can easily become vulnerable to abuse of various structures and processes of power and to examine the inter-dependence of and linkage between Human Rights and democracy, pluralism, development, ecological balance, peace and harmony at the national and international levels.
- d. To make people aware of "Human Rights Duties", privileges, conduct training camps & workshops, establish old age homes, residential/vocational schools & colleges, research & medical colleges and Human Rights Camps.



- e. To promote art & culture, maintain, encourage, and assist/help setting up Centers for promotion of Human Rights.
- f. To promote social progress and better standards of life and activity in cooperation with the Government of India and other countries to promote human rights education.
- g. To develop a more distinctive and effective role for the International Court of Justice to fulfill the Human Rights and spread the messages/values of Human Rights by way of Human Rights education.
- h. To open training camps and workshops for the development of arts, plays and culture and raise funds through subscriptions, donations, trade to fulfill the aims and objects.
- i. To establish and conduct centers of treatment and rehabilitation for the victims of violators of Human Rights.
- j. To actively join hands with the Government of India and other countries to promote Human Rights education and help legal, social and economic discrimination against women and their exploitation in different ways.
- k. To publish books, encyclopedias, monographs, journals and directories on Human Rights and study and prepare reports on the violation, etc.
- l. To effectively work for gender inequalities, exploitations and injustice as also to encourage / assist talented artists, poets, singers, writers, social workers, journalists, doctors, judges, etc.
- f. To organize and participate in cultural programmes to foster a spirit of nationalism to achieve co-operation in solving various problems of economic, social, cultural or humanitarian character and in promoting and encouraging respect for human rights

### **INFORMATION TECHNOLOGY**

- a. To setup information centers at block/district/state level to help the people about latest developments. If possible these types of centre can be setup at village level also.

### **LEGAL LITERACY**

- a. To make rural people conscious of their rights and responsibilities, enabling them to stiff for honest efficient administration, speedier justice and for better education, health and other services.
- b. To provide women in destitute legal aid and adequate counseling.

### **LIVESTOCK MANAGEMENT**

- a. To establish research center for high milk yielding varieties of buffaloes cows etc.



- b. To setup a semen bank for artificial insemination of animals.
- c. To establish hospital and mobile Medicare facilities for livestock.

### MARKETING FACILITIES

- a. To setup OWN MARKET with the help of center and state govt.
- b. To establish retail outlets for the farmers in rural/urban areas with a minimum of 20-25 outlets at different localities in Delhi for direct sale to consumers.
- c. To setup cold storage for the farmers facilitate training, market linkage to the people including unemployed youth and craftsmen engaged in small and cottage industries.
- d. To install processing plant for the farmers so that surplus stock could be converted into fast food items.
- e. To provide technological and marketing know-how and process to farmers.

- a. CRO will make best efforts to work on welfare of minority section.
- b. CRO will work to promote health awareness, education and all other sectors among the minorities.

### NETWORKING

- a. To setup network of village, block, district, state and national and international level NGO's involved in development sector for better working and implementation of various schemes, funding sources and to provide more benefit to target groups.

### PROCESSING

- a. To work for processing of plants, herbs, shrubs etc. for medicines.
- b. To implement schemes of food processing sector.
- c. To setup food processing units, food parks etc.
- d. To carry out manufacturing marketing of low cost building material.
- e. To understand research & development projects.
- f. To setup demonstration units & pilot projects.
- g. To setup food & agro processing units.

### PUBLICATIONS

- a. To setup press & print literature, magazines & newspaper for social welfare.



- b. To prepare brief curriculum for illiterate people and non-financial education.

## RESEARCH AND SURVEYS

- a. To conduct various research studies in the field of Agriculture, RCH, Pollution Control, Panchayati Raj, AIDS, Bio-Diversity, Education, Environment, Health, Watershed Management etc.
- b. To conduct surveys on various topics related to development aspect of community
- c. To carry out surveys related to the socio-economic aspects of rural and urban life
- d. To compose herbal garden to enhance methodology of Indian System of Medicine & homeopathy.

## SEMINARS / TRAINING / CAMPS / WORKSHOPS

- a. To conduct seminars, conferences, lectures at grass root level, District, state and national level on all matters and problems affecting the people.
- b. To make arrangements for such caliber farmers as are prepared to go abroad to take part in debates and discussion on transfer to latest technology and marketing processes from labs and research centers to land.
- c. To establish training centers for the farmers to impart knowledge about the latest technology to be adopted by them.
- d. To organize seminars/camps/workshop/transportations and rallies on the various activities for betterment of the rural & urban poor irrespective of casts and creed .
- e. To organize voluntary blood donation camps.
- f. To impart training in horticulture, sericulture, pisci culture, floriculture, poultry, piggery, goatry, mushroom production, computer application production, stenography, knitting & tailoring, beautification trade, readymade garments, leather goods, handlooms, khadi & jute diversification textile, handicraft & traditional occupation to the poor & needy people and take above mentioned programmes for providing themselves a sustainable employment.
- g. To setup coaching centers for SC/ST/OBC and others.
- h. To conduct various refresher courses and orientation training programmers.

### YOUTH ACTIVITIES

- a. To organize and conduct vocational training courses for youth.
- b. To help youth to acquire knowledge skills' to awaken social consciousness & responsibility.
- c. To evolve and develop the concept of methodology of community work among youth.
- d. To initiate and organize need-oriented rural/urban development programmes.
- e. To organize and implement schemes that would help poor people to increase their income.
- f. To plan and execute youth exchange programmes; to organize tour and picnics in and out of the country.
- g. To impart education and training of the basis of youth organisation methods and practices.
- h. To organize national integration camps.
- i. To conduct various camps i.e. trekking camps, snow skiing, water sports, flying and eco development caps etc.
- j. To organize debates and declamation contest, speech.
